

Membership of MARS

1. Those desirous of becoming members of MARS, will have to apply in writing (in the prescribed form) to the society.
2. The membership will be granted based on scrutiny and approval by the management committee of the society.
3. The following qualifications are essential for membership:-
 - (a) Age should not be less than 45 years and not be more than 75 years.
 - (b) Should be a citizen of India.
 - (c) Has faith and follows the rules of the society.
 - (d) Should have a good moral character.
4. Ordinary Membership. On approval by the management committee, the membership will be granted to the applicant, subject to payment of Rs 3000/- as membership fee and an annual subscription of Rs 1000/-. Ordinary membership will be for two years and can be renewed on request.
5. Life Membership. The management committee may also consider grant of Life Membership either initially to the applicant or subsequently to a member based on the request by the member. The Life membership fee will be Rs 10000/- initially, with an annual subscription of Rs 1000.
6. Honorary Members. The managing committee of the society can offer honorary membership to eminent persons.

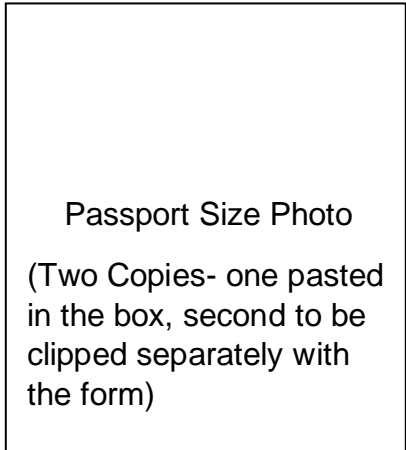
